Heard arguments exchanged by both the parties. Rejoinder submitted by Sh. Rakesh Bansal, authorised representative of the Applicant taken on record. It is found that the petition regarding unauthorised use U/s 126 of Electricity Act,2003, is lying for adjudication before the Court of Divisional Commissioner, Shimla, which is the competent Court having jurisdiction on such matters. Therefore, the representation of the applicant regarding refund on account of delay, cannot be considered till pendency of the case before the Divisional Commissioner. Thus, the representation of the applicant M/s JSK International, Village Gullarwala, Baddi, Distt. Solan (HP) is disposed off on jurisdictional ground.
