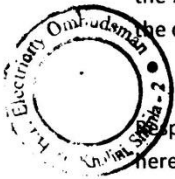

Case called, both parties were heard. Earlier the Respondent No. 2 had informed vide communication dated 23/07/2020 that they are going to assail the orders of the Consumer Grievances Redressal Forum in Hon'ble HP High Court. The Counsel for Respondents informed that the reconciliation between the parties is in process and they will submit either the reconciliation proceeding within next 10 days or submit their reply on merit.

Since the earlier complaint filed at the Consumer Grievances Redressal Forum was in the name of M/S H.N.
