Case called, both parties were heard. The reply have been filed by the Respondents through e-mail dated 11/12/2020 alongwith details of the case at Hon'ble HP High Court. The Respondents could not clear their stand on certain conflicting issues contained in submission of request on 18/02/2013 for PDCO by M/S Rama Steel, earlier occupier of the premises which they states that the same is not present in their record, letter dated 16/04/2015 of M/S Rama Steel wherein they have informed the then CMD of the Respondent Board that the calculations have been submitted under duress and are miscalculations, letter dated 29/05/2013 by Respondent No. 2 to the HPFC intimating that they have credit balance of Rs 1,56,02,798/- in respect of Consumer M/S Rama Steel after liquidating the BG of RS 2,21,28,000/- available with them and the statement of balance due from the firm M/S Rama Steel amounting to Rs 1,52,33,741/- for which they have filed a case at Hon'ble HP High Court (Which is still at Service stage after filing a suit No. 31 of 2016).

The Counsel for Respondents contested that the Complainant can't produce new evidence now (Letter dated 18/02/2013 for PDCO) at the sage of appeal to which the Counsel for the Complainant informed that they had submitted the same at the time of written submissions at Consumer Grievances Redressal Forum.
