Public Notice

Subject: Draft regulations i.e. the Himachal Pradesh Electricity Regulatory Commission (Promotion of Generation from the Renewable Energy Sources and Terms and Conditions for Tariff Determination) Regulations, 2017.

The Commission had issued a public notice in the newspapers i.e. "The Tribune" and "Amar Ujala" on 20.08.2017 & 21.08.2017 respectively regarding filing of objections/suggestions on the draft regulations i.e. the Himachal Pradesh Electricity Regulatory Commission (Promotion of Generation from the Renewable Energy Sources and Terms and Conditions for Tariff Determination) Regulations, 2017.

The public hearing, as per the aforesaid notice was scheduled to be held on 16.09.2017 on or after 2.30 PM onward, on the onset of the public hearing, many stakeholders requested the Commission for adjournment of the hearing, on account of various reasons, however, keeping in view that some of the stakeholders, present in the hearing, wanted to express their view point on the aforesaid draft regulations, so the same was held as per scheduled date and time. The view point expressed by these stakeholders in the public hearing on 16.09.2017 shall be taken into consideration accordingly.

Taking into consideration the request of adjournment of hearing by the stakeholders, the Commission decides to conduct another public hearing on the subject matter which is scheduled to be held on **07.10.2017** on or after **11.30 AM** onwards in the Commission's court room at Shimla.
